The products of ARNODECLERCQ are natural products, so they may contain differences, eg the wood used "Iroko and Oak" are natural products. Wood is a material that "lives" and thus can deform limited. Tearing and bursting in the wood can occur due to time by drying out the wood. Every product manufactured by ARNODECLERCQ is handmade and may differ from piece to piece. Wood contains specific grain drawings and therefore can differ from color. The colors of the ARNODECLERCQ products are done by combustion (burning), sanding and waxing, which is not harmful to the environment or human health. Color differences on these artisan products are possible. The products may differ in part from pictures displayed in catalogs, website, advertising and social media. All this does not give rise to cancellation or any damages to the order.

Every complaint must be made within seven days after receipt of the goods to be sent by means of a registered letter addressed to the registered office of the ARNODECLERCQ. The small differences are justified by the artisan character of the goods sold.
